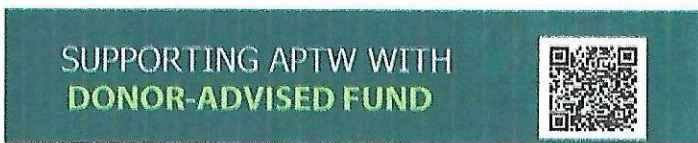

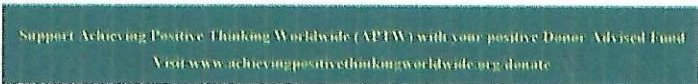

GIVE - by recommending to Fidelity Charitable DAF, that APTW receive a grant from your donor-advised fund.

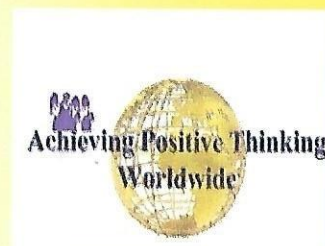
